Crossborder Infection and Environmental Hazards: Challenges and Solutions

Cross-border regions often have the treat of international infectious disease outbreaks and environmental cross-border accidents. There is an urgent need of rapid transnational detection and response, improved international cooperation and integration of surveillance, and response systems. This symposium will highlight the challenges for EU regions – including differences in legislation, medical infrastructure and culture – and discuss shared solutions such as euregional protocols for public health and hospitals or real-time cross-border dashboards.

Finding of the sup-project groups CBRN red (protection, behavior, detection) and white (countermeasures, treatment, medical provision), risk awareness, prospects

The symposium will demonstrate coordinated cross-border rescue operations by the country's specific resources and competences. Additionally, the utilization of several specialized competences will be demonstrated. The competences of the various consultants (medical, chemical, fire department, technical assistance organization (THW) etc.) should be determined based on measurements, examples, advice from the population in CBRN hazardous situations. The purpose of doing this is to get a broad hazard estimation.

EUMED, offering euregional help to each other in case of urgent medical cases - an archetype for Europe

- 1 Central European Trauma Network (BTCCE = Boundless Trauma Care Central Europe)
- 2 Euregio-protocol for rescue operations/TEMRAS
- 3 EUMIC laying down borders in the area of interhospital transportation of patients in intensive care
- 4 Vehicle demonstration (vehicles for intensive care patients)

There are different sorts of trauma cooperation projects in central Europe. Especially the experience in cross-border cooperation in this field will strengthen the learn effect and direct the attention of legislator's towards cross-border issues. The cross-border practices in the Euregio Meuse-Rhine have saved many lives so far.

On the basis of the national protocol on rescue operations in the Netherlands bilingual versions (German/Dutch) have been created. The vision is to create uniform protocols for the Euregio Meuse-Rhine. Telemedic support (TEMRAS) of the helpers could also be of additional benefit. This cooperation of rescue services, that has been in practice for several years, could be brought to a new level by increased standard of care, standard of quality, and standard of safety. The protocol in the Euregio could also be used as an archetype for all of Europe.

Transport of ICU patients is risky and takes a lot of people, resources and money. The Eumicproject wants both a concept to improve the quality of care and efficiency and also conduct a study to establish quality criteria and transport modalities.
